# INTERNATIONAL FINANCIAL VERIFICATIONS

International undergraduate applicants must demonstrate sufficient funding to cover educational expenses while attending Ouachita Baptist University. As a part of your application, you will submit the International Financial Verification Form with corresponding reliable financial documentation. Please read this document in its entirety.

Ouachita Baptist University will not make an admissions decision until all required financial forms and documents are submitted.

## ACADEMIC YEAR 2019-2020 INTERNATIONAL UNDERGRADUATE COSTS\* (2 SEMESTERS)

**Tuition** \$27,280.

University Fees (fees include: in-room cable TV, high speed internet, local telephone service; entertainment events, music & plays; athletic events & use of sporting facilities; lecture series; laundry; yearbook; and university health services.) \$620.

**Room** (double occupancy) \$4,000. Single rooms and premium rooms in the Student Village are available at a higher rate.

Board (Meal plan) \$4,000.

Other expenses - Health Ins. (annual) \$1,100.

Books (estimated) \$2,500.

Total \$40,500.

\*The billed costs at Ouachita Baptist University have increased approximately 3-5% annually. Information detailing the exact costs for next year will be sent in late March/early April. Students are expected to cover any increase in the above expenses each of enrollment.

### STEPS TO COMPLETE FINANCIAL VERIFICATION

#### 1. Indicate your financial status

Some international students have the ability to fully fund their education and are not seeking any financial assistance. Other international students do not have sufficient funding and need financial assistance in order to attend Ouachita Baptist University. Using the projected costs of enrollment, determine your financial status and indicate it in Section C. Students and their parents must complete the International Financial Verification Form regardless of financial status as a part of the application process.

#### 2. Complete and upload the international financial verification form

In Section D, provide an overview of your family's financial situation. In Section E, note the type and amount of funds tjat you intend to use toward your educational expenses. Financial resources that will not be used toward your educational expenses, or amounts in excess of the projected expenses, should not be included in this table (see Section D.) The form must be completed and signed by both student and parent.

#### 3. Upload corresponding financial documentation

Applicants must upload verifying documents for all funding sources.

Examples of reliable documentation of funding sources:

- Documentation of Parents' Annual salary: Income statement, pay stub, letter from parent's employer, or annual income tax return, translated into English.
- Parent's/Student's Bank Statement(s): Recent bank statement(s) translated into English
  and in US dollars. If the translation is not an official translation provided by the bank, the
  translation should be notarized.
- If you have a sponsor or other funding source, such as a relative, government agency, outside scholarship, or a church stipend, please submit an affidavit of support letter signed by that sponsor-notarized and translated into English. Submit corresponding documentation of the sponsor's source of contribution toward your expenses (income/bank statement.)
